240/24. To receive and accept apologies for absence.

Apologies received and accepted from Cllr's P Burns M Minogue and D Riley and Cumberland Councillor L Jones-Bulman.

241/24 To approve and sign the minutes of the meeting held on 9th July 2024.

Resolved that the minutes be approved and signed.

242/24 Declarations of interest of items on the agenda.

Cllr Ford declared an interest in iSH Healthwatch and CMCIC. Cllr Eldon declared an interest in the safer streets project, Cllr J Hully declared and interest in RNEC

243/24 Applications to the Clerk for dispensations.

None received.

244/24 Public/Elected Officer participation.

Mr David Allen Cumbria Police Fire and Crime commissioner introduced himself to the meeting after his first 100 days in the role explaining that he wanted to attend as many Town Council meetings as possible. Mr Allen explained the purpose of the current survey welcoming comments from Councillors and the wider public about what they wanted the role of crime commissioner to do, he explained the survey can be completed online and would leave hard copies for

distribution. Priorities raised included 'more police on the streets' which is something everybody wants with work to be done on follow up response as well as actual initial attendance. Over the next 5 years the Governments had committed to 10K new police officers and within Cumbria this equated to between 50 and 75 new staff with the intention of placing them within the neighbourhood police teams and not in the control room. Cumbria had received a good HMIC (His Majesty's Inspectorate of Constabulary) report which had commented on the need to be victim focussed. He explained he would also be active in National debate to ensure Cumbria is not forgotten. Mr Allen fielded questions from Councillors including his thoughts on the recent unrest, the possibility of extra CCTV to enhance what is already provided by the Town Council, and the use of social media to engage with communities.

Cllr Eldon addressed the meeting in his capacity as Cumberland Councillor explaining there had been a further delay to the announcement of the return of the service 22 bus but was hopeful this would happen soon, a question from a resident was read asking for clarity on the route the service would take with Cllr Eldo saying he hoped the route would match the one that was withdrawn. An officer from Cumberland council had visited the Town the previous week to look at empty properties within the town and would advise on what action the council can and will take to help with this situation.
